

# Wiltshire's next LTP – your chance to have your say.

Wiltshire Council have launched a consultation on their next Local Transport Plan and COGS members may wish to use this opportunity to make their views known on some of the issues which are raised. The document – Wiltshire Local Transport Plan 2011 Consultation Issues Paper – is available on WC's website at <u>www.wiltshire.gov.uk/transport/transport-policy-service/transport-publications.htm</u>, and responses need to be submitted by **May 29<sup>th</sup>**.

This document is looking at overall vision and strategy and approaches to be taken rather than specifics. However there are some points which cyclists may wish to comment on:

• There was a 'County Cycle Action Plan' developed for WCC's first LTP. But it is now suggested (Section 6.10 of the document) that the County prepares a two-wheeler strategy to cover policies for motorcycles, mopeds and scooters as well as cycles rather than preparing separate strategies for bicycles and 'powered two-wheelers'.

COGS feel that cycling should have a strategy in its own right – it is a healthy and entirely green mode of transport and should **not** be covered in the same strategy as powered two-wheelers.

• The questionnaire asks whether the long-term strategy should follow an 'established', 'balanced' or 'radical' approach.

 $\widehat{COGS}$  believe that the **radical** approach (which Wiltshire Council define as 'prioiritise sustainable transport services and measures and discourage the use of the private car in urban areas' is the right way forward for the first quarter of the  $21^{st}$  century which this plan will cover.

### What's an LTP? Why does it matter?

Local Transport Plans (LTPs) have been a statutory requirement since the Transport Act 2000. They are the means by which local transport authorities bid for government funding and report progress on their transport plans. Here in Salisbury LTPs were produced by Wiltshire County Council & now by the new unitary Wiltshire Council (WC).

Previously LTPs ran for a 5 year periods, but the rules are being revised for this  $3^{rd}$  round of LTPs (LTP3) and local authorities can now choose how long they want their LTP to run, and the 'long term strategy' can be a separate document from the shorter term 'implementation plan'.

WC have proposed that their LTP3 'strategy' document will cover the period 2011 to 2026, with implementation plans covering 3 year periods. So this may be your last chance to have a say on Wiltshire's transport strategy for 17 years – make the most of it!

### **COGS Summer Rides & Events**

While most COGS members are quite content with the gentle rides in the summer rides programme, Jeff Scholefield – who entertained us at our last AGM with the story of his Trans-Am ride last year – has headed across the pond again.

This time Jeff is cycling the Lewis and Clark trail, which takes it name from two pioneers who followed this route to the west in 1804. Their journey lasted three years and took them through what are now 11 of the American states. Jeff will be following their footsteps – but taking somewhat less time we trust – his journey leads from St Charles Missouri to the west coast, and his first week's diary reports from the Katy Trail, a 225 mile (365 km) bike path stretching across most of the state of Missouri.

"The Katy Trail outside of towns is generally enclosed by trees and often has steep cliffs bordering on the right and the Missouri River on the left. Everywhere was lush; flowers in bloom and wild life, birds, frogs, turtles, squirrels of two types, were seen easily and often. The surface of the Trail is hard packed crushed limestone which proved to be harder to cycle on than I had expected. It was because of the rain the top surface was slightly soft so as well as slowing me down, it also gradually covered my bicycle, trailer and RAF Ensign in a light beige coloured mucky layer."

At the end of his first week Jeff had covered 241 miles and reported: "The first week is done: Hard pedalling in not very nice weather for everyday since Monday. Yet again I am amazed at the generosity, warmth and friendliness of the American people. I have enjoyed my first few days on the bike but hope that the coming days will become easier, as my experience tells me it will. The Katy Trail is behind me and Kansas, and then Nebraska beckons me in the next week."

Jeff plans to complete the trip and return to the UK in July – in time to join some of the COGS summer evening rides. We don't anticipate he'll have any problem keeping up!

**Thanks** to Nick Cowan & his team in Wiltshire Council's rights of way service who have responded to comments from COGS and done some very useful work to get the surface of Green Lane (from Bishopdown to Ford) into a better state for cyclists. Give it a try sometime!
